



Embassy of Italy in Tehran Checklist for Tourist Visa

List of Mandatory Documents

1	Application Form completely filled and signed with two (2) Signatures (BOTH parents should sign minors the application form).
2	Two (2) recent photographs 35x40 mm with white back ground (not photoshopped) not older than 6 months
3	Passport with 90 days validity from the date of return from the Schengen area and with at least 2 non-used visa pages.
4	Hotel Booking including the total price covering the stay during entire trip. OR Invitation letter from an Italian citizen or a foreigner resident in Italy according to the format provided on the website: Required Documents (visametric.com) (invitation letter should be accompanied by one of the below mentioned identity document): Copy of Valid passport of Italian citizen OR Copy of Valid Identity card of Italian Citizen Foreigner resident in Italy requires submitting a Copy of resident permit. Note: if the inviter declares that he will host the visa applicant at his home, documents relating to the inviter's place of residence (lease agreement and registration receipt) must be provided. The request does not apply to Italian/EU citizens.
5	Copies of Passport (first page), previous Schengen (with entry and exit stamps), UK and US visa.
6	All MINORS are required to provide the consent letter translated by legal translator in English or Italian attested by the Ministry of Justice & Ministry of Foreign affairs.
7	Copy of Work Documents (Translated by legal translator in English or Italian) For Executives and members of the board of companies: Recent Official Gazette (not older than three years) where the constitution and registration of the enterprise, as well as the name of the applicant are recorded. In case the Official Gazette is older than three years, the applicant must also submit more recent Official Gazette (not older than three years) to highlight possible changes on the company's constitution or a registry office certificate declaring that the company is still active despite no changes have been registered. Self-employed Valid working license or valid Commercial Paper. Private or State employees Lists of the insurance fees (Social Insurance) payment relating to the last six months or personal card of affiliation to a State or State controlled organization or Labor Contract. Optional: Presentation letter.
8	Original Documents proving financial means of support during your stay in Italy: Bank Statement for last six months showing the transactions signed and stamped by bank in English. Optional: Bank guarantee from Italy & Title Deed
9	Birth Certificate (Translated by legal translator in English or Italian)
10	Copy of Medical Travel Insurance with coverage of Minimum 30,000 € covering 2days more than the entire trip.
11	Copy of Airline ticket or reservations

Declaration:

I understand that an application without a complete set of documents (as per the checklist above) may result in refusal of my visa application.
The submission of a complete file does not guarantee the issuance of a visa.
The applicant himself should submit the documents personally at the appointment date.
The Italian Embassy in Iran reserves the right to request additional documents if deemed necessary for a better evaluation of visa application.

NOTE: Documents other than those specified in the checklist will not be accepted.
